

# Terms and Conditions

## 'ACTIVE MINUTES CHALLENGE' PHASE 1 PROMOTION - TERMS AND CONDITIONS

### 1.OFFER AND ELIGIBILITY

2.3 All other applicable fees and charges in respect of the membership will be payable in accordance with the applicable membership terms. Your membership will otherwise be governed by such membership terms.
